### Biographies



## Prof Edith Heard DG of European Molecular Biology Laboratory

Edith Heard, FRS, has been internationally recognized for her ground-breaking discoveries about the mechanisms of epigenetics that enable mammals to regulate gene expression, which is

essential for life.

She is the Director General of the European Molecular Biology Laboratory in Heidelberg, Germany, and Chair of Epigenetics and Cellular Memory at the Collège de France, Paris. A former director of the Genetics and Development Biology unit at the Institut Curie, she is also a Fellow of the Royal Society in the UK. Edith and her laboratory have been recognised by many prizes, most recently the L'Oréal-UNESCO For Women in Science International Award, the Hansen Family Award, the Karl Bonhoeffer Award, Inserm Grand Prix, the European Society for Human Genetics Award and the Prix René et Andrée Duquesne of la Lique contre le cancer.

Edith is an Honorary Fellow of Emmanuel College, at the University of Cambridge, a Fellow of the Royal Society, an EMBO Member, a Foreign Associate of the National Academy of Sciences (US), an International Member of the National Academy of Medicine (US), a Member of the German National Academy of Sciences Leopoldina, an International Member of the Royal Academy in Denmark and she has an Honorary Degree Doctor of Science Honoris causa at the University of Cambridge and an Honorary Professor Degree at the University of Heidelberg.



## Caroline Nokes MP MP for Romsey and Southampton North

Caroline is the Member of Parliament for Romsey and Southampton North and the current Chair of the Women and Equalities Select Committee in Parliament. Since her election in 2010 she has served as a Minister in the Department for Work and Pensions, the Cabinet Office and was Minister

of State for Immigration in Theresa May's Cabinet. Immediately prior to becoming an MP she was the Chief Executive of an animal welfare charity. Caroline is currently the co-chair of the APPG for Muslim Women, Vice Chair of "Show Racism the Red Card" and as Chair of the Select Committee is leading the inquiry into menopause in the workplace.





#### Wendy Waring Global Programme Lead, British Council

Wendy Waring is the Global Programme Lead for Science at the British Council, the UK's international organisation for cultural relations and educational opportunities. Wendy is responsible for overseeing the successful delivery of British Council's science portfolio

of work including management of large-scale programmes such as the Newton Fund. Wendy leads an extensive UK and global team spanning 5 regions and 16 countries, with £86M of Newton Fund grants having been awarded over the past 7 years. She has over 30 years of experience delivering and managing projects and programmes across the school and HE sector ranging from international student mobility programmes, professional development for teachers and education practitioners to linking opportunities for schools. Wendy is a linguist with an honours degree from the University of London (Goldsmiths College) in French and Classical Greek. She has an MA in English Language teaching (Queen's University Belfast) and has lived and worked abroad. She currently lives and works in Belfast



#### Elisabeth Kohler Head of Gender Equality Unit, CNRS

Elisabeth Kohler, Senior Science Policy Officer, has been the Head of the Gender Equality Unit at the CNRS since 2018 She has a long experience in different fields at CNRS, ranging from scientific information to innovation policies, European project

management and international cooperation. She has worked for twelve years as manager for European and international affairs at the Institute for Earth Sciences and Astronomy at CNRS. She coordinated several EU-funded projects and was member of the sherpa group of the high-level steering group of the European Innovation Partnership on Raw Materials. She holds a Master degree in History.





### Dr. Roshni Mooneeram Head of Equality, Diversity & Inclusion Office at the European Molecular Biology Lab

Dr Roshni Mooneeram is Head of the Equality, Diversity and Inclusion Office at EMBL, the European Molecular Biology Lab, with responsibility for all sites in Germany, France, the UK, Spain and Italy. She is also a global consultant in Diversity and

Inclusion and Honorary Associate Professor of the University of Nottingham. She has previously played a leading role in the internationalisation of higher education with the setting up the University of Nottingham in China. She has worked as a consultant in Diversity and Inclusion to global organisations such as Accenture, helping them with their target of gender parity by 2025. She was recently commissioned to write a strategy for the African Union: Building Resilience to Foster African Human Capital through Girls' and Women's Education for Sustainable development. Roshni is from East Africa, Mauritius, and has lived and worked in Africa, Europe and Asia.



#### Dr Karen Salt UKRI Deputy Director – Culture and Environment

Dr Karen Salt has over 27 years' worth of experience working in and with communities, organisations, charities and governmental bodies. An expert on systems of governance, she

has managed large research teams and collaborated on a number of research projects, including those exploring trust and collective governance in technology. She currently supports UKRI's External Advisory Group for Equality, Diversity and Inclusion as its Deputy Chair and held a previous appointment as a member of the Arts and Humanities Research Council's Advisory Board. She recently moved from directing the Centre for Research in Race and Rights, based at the University of Nottingham, to her current role as Deputy Director for R&D Culture and Environment within UKRI, a policy area that includes cross-cutting topics, such as research integrity and research culture, where she contributes senior leadership to UK and international conversations about research policy.
